
Percentage of High School Students Who Rarely or Never Wore a Seat Belt,* by Sex,† Grade, and Race/Ethnicity,† 2019


Percentage of High School Students Who Rarely or Never Wore a Seat Belt,* 2003-2019[†]




Percentage of High School Students Who Rode with a Driver Who Had Been Drinking Alcohol,* 2017-2019[†]







Percentage of High School Students Who Carried a Weapon,* by Sex,† Grade, and Race/Ethnicity,† 2019





Percentage of High School Students Who Carried a Weapon on School Property,* 2003-2019[†]



Percentage of High School Students Who Carried a Gun,* by Sex,† Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Did Not Go to School Because They Felt Unsafe at School or on Their Way to or from School,* 2003-2019[†]

Percentage of High School Students Who Were Threatened or Injured with a Weapon on School Property,* by Sex,† Grade, and Race/Ethnicity, 2019



Percentage of High School Students Who Were Threatened or Injured with a Weapon on School Property,* 2003-2019[†]






Percentage of High School Students Who Were in a Physical Fight,* 2003-2019[†]




Percentage of High School Students Who Were Ever Physically Forced to Have Sexual Intercourse,* 2003-2019[†]

Percentage of High School Students Who Experienced Sexual Violence,* by Sex,† Grade, and Race/Ethnicity, 2019





Percentage of High School Students Who Experienced Sexual Dating Violence,* by Sex,† Grade, and Race/Ethnicity, 2019






Percentage of High School Students Who Experienced Physical Dating Violence,* by Sex, Grade, and Race/Ethnicity, 2019

Percentage of High School Students Who Were Bullied on School Property,* by Sex,† Grade,† and Race/Ethnicity,† 2019




Percentage of High School Students Who Were Bullied on School Property,* 2017-2019†


Percentage of High School Students Who Were Electronically Bullied,* by Sex,† Grade,† and Race/Ethnicity, 2019


Percentage of High School Students Who Were Electronically Bullied,* 2017-2019[†]




Percentage of High School Students Who Seriously Considered Attempting Suicide,* 2003-2019†

Percentage of High School Students Who Made a Plan About How They Would Attempt Suicide,* by Sex,† Grade, and Race/Ethnicity, 2019





Percentage of High School Students Who Made a Plan About How They Would Attempt Suicide,* 2003-2019[†]






Percentage of High School Students Who Attempted Suicide,* 2003-2019[†]




Percentage of High School Students Who Ever Tried Cigarette Smoking,* 2003-2019†

Percentage of High School Students Who First Tried Cigarette Smoking Before Age 13 Years,* by Sex,† Grade, and Race/Ethnicity, 2019






Percentage of High School Students Who First Tried Cigarette Smoking Before Age 13 Years,* 2017-2019[†]


Percentage of High School Students Who Currently Smoked Cigarettes,* 2003-2019[†]


Percentage of High School Students Who Currently Smoked Cigarettes Frequently,* 2003-2019[†]


Percentage of High School Students Who Currently Smoked Cigarettes Daily,* 2003-2019[†]

Percentage of High School Students Who Smoked More Than 10 Cigarettes Per Day,* by Sex, Grade, and Race/Ethnicity, 2019




Percentage of High School Students Who Ever Used an Electronic Vapor Product,* by Sex, Grade,† and Race/Ethnicity, 2019

Percentage of High School Students Who Ever Used an Electronic Vapor Product,* 2015-2019[†]



Percentage of High School Students Who Currently Used an Electronic Vapor Product,* by Sex, Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Currently Used an Electronic Vapor Product,* 2015-2019[†]

Percentage of High School Students Who Currently Used Electronic Vapor Products Frequently,* by Sex, Grade,† and Race/Ethnicity,† 2019






Percentage of High School Students Who Currently Used Electronic Vapor Products Frequently,* 2015-2019[†]

Percentage of High School Students Who Currently Used Electronic Vapor Products Daily,* by Sex, Grade,† and Race/Ethnicity,† 2019






Percentage of High School Students Who Currently Used Electronic Vapor Products Daily,* 2015-2019[†]



Percentage of High School Students Who Currently Used Smokeless Tobacco,* by Sex,† Grade, and Race/Ethnicity, 2019




Percentage of High School Students Who Currently Used Smokeless Tobacco,* 2017-2019[†]



Percentage of High School Students Who Currently Smoked Cigars,* 2009-2019†




Percentage of High School Students Who Currently Smoked Cigarettes or Cigars,* 2009-2019†








Percentage of High School Students Who Currently Smoked Cigarettes or Used Electronic Vapor Products,* 2015-2019[†]

Percentage of High School Students Who Tried to Quit Using All Tobacco Products,* by Sex, Grade, and Race/Ethnicity, 2019




Percentage of High School Students Who Tried to Quit Using All Tobacco Products,* 2017-2019[†]



Percentage of High School Students Who Had Their First Drink of Alcohol Before Age 13 Years,* 2003-2019[†]





Percentage of High School Students Who Currently Drank Alcohol,* 2003-2019[†]



Percentage of High School Students Who Currently Were Binge Drinking,* by Sex, Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Currently Were Binge Drinking,* 2017-2019[†]



Percentage of High School Students Who Usually Got the Alcohol They Drank by Someone Giving It to Them,* 2013-2019[†]






Percentage of High School Students Who Tried Marijuana for the First Time Before Age 13 Years, 2003-2019*

Percentage of High School Students Who Currently Used Marijuana,* by Sex, Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Currently Used Marijuana,* 2003-2019†







Percentage of High School Students Who Ever Used Cocaine,* 2003-2019[†]




Percentage of High School Students Who Ever Used Inhalants,* by Sex, Grade,† and Race/Ethnicity, 2019



Percentage of High School Students Who Ever Used Methamphetamines,* 2003-2019[†]






Percentage of High School Students Who Ever Took Steroids Without a Doctor's Prescription,* 2003-2019[†]

Percentage of High School Students Who Were Offered, Sold, or Given an Illegal Drug on School Property,* 2003-2019[†]






Percentage of High School Students Who Ever Had Sexual Intercourse, 2003-2019*


Percentage of High School Students Who Had Sexual Intercourse for the First Time Before Age 13 Years, 2003-2019*


Percentage of High School Students Who Had Sexual Intercourse with Four or More Persons During Their Life, 2003-2019*



Percentage of High School Students Who Were Currently Sexually Active,* 2003-2019[†]





Percentage of High School Students Who Drank Alcohol or Used Drugs Before Last Sexual Intercourse,* 2003-2019[†]




Percentage of High School Students Who Used a Condom During Last Sexual Intercourse,* 2003-2019[†]

Percentage of High School Students Who Used Birth Control Pills Before Last Sexual Intercourse,* by Sex, Grade, and Race/Ethnicity,†2019



Percentage of High School Students Who Used Birth Control Pills Before Last Sexual Intercourse,* 2003-2019[†]


















Percentage of High School Students Who Did Not Use Any Method to Prevent Pregnancy,* 2003-2019[†]

Percentage of High School Students Who Had Obesity,* by Sex,† Grade, and Race/Ethnicity,† 2019





Percentage of High School Students Who Had Obesity,* 2003-2019[†]



Percentage of High School Students Who Were Overweight,* by Sex, Grade, and Race/Ethnicity,† 2019






Percentage of High School Students Who Were Overweight,* 2003-2019[†]



Percentage of High School Students Who Described Themselves As Slightly or Very Overweight, by Sex,* Grade, and Race/Ethnicity,* 2019





Percentage of High School Students Who Were Trying to Lose Weight, by Sex,* Grade, and Race/Ethnicity,* 2019





Percentage of High School Students Who Did Not Drink Fruit Juice,* by Sex,† Grade, and Race/Ethnicity,† 2019






Percentage of High School Students Who Did Not Drink Fruit Juice,* 2015-2019†




Percentage of High School Students Who Did Not Eat Fruit,* 2015-2019[†]




Percentage of High School Students Who Did Not Eat Fruit or Drink 100% Fruit Juices,* 2015-2019[†]



Percentage of High School Students Who Ate Fruit or Drank 100% Fruit Juices One or More Times Per Day,* 2015-2019[†]





Percentage of High School Students Who Ate Fruit or Drank 100% Fruit Juices Two or More Times Per Day,* 2015-2019[†]



Percentage of High School Students Who Did Not Eat Green Salad,* by Sex,† Grade, and Race/Ethnicity,† 2019






Percentage of High School Students Who Did Not Eat Green Salad,* 2015-2019[†]

Percentage of High School Students Who Did Not Eat Potatoes,* by Sex, Grade,† and Race/Ethnicity, 2019




Percentage of High School Students Who Did Not Eat Potatoes,* 2015-2019[†]

Percentage of High School Students Who Did Not Eat Carrots,* by Sex, Grade, and Race/Ethnicity,† 2019




Percentage of High School Students Who Did Not Eat Carrots,* 2015-2019[†]

Percentage of High School Students Who Did Not Eat Other Vegetables,* by Sex, Grade,† and Race/Ethnicity,† 2019






Percentage of High School Students Who Did Not Eat Other Vegetables,* 2015-2019[†]

Percentage of High School Students Who Did Not Eat Vegetables,* by Sex,† Grade,† and Race/Ethnicity,† 2019





Percentage of High School Students Who Ate Vegetables One or More Times Per Day,* by Sex, Grade, and Race/Ethnicity,† 2019





Percentage of High School Students Who Ate Vegetables Two or More Times Per Day,* by Sex, Grade, and Race/Ethnicity,† 2019





Percentage of High School Students Who Ate Vegetables Three or More Times Per Day,* by Sex, Grade,† and Race/Ethnicity, 2019







Percentage of High School Students Who Did Not Drink a Can, Bottle, or Glass of Soda or Pop,* 2007-2019[†]





Percentage of High School Students Who Drank a Can, Bottle, or Glass of Soda or Pop Two or More Times Per Day,* 2007-2019[†]



Percentage of High School Students Who Did Not Drink Milk,* by Sex,† Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Did Not Drink Milk,* 2017-2019[†]

Percentage of High School Students Who Drank One or More Glasses Per Day of Milk,* by Sex,† Grade,† and Race/Ethnicity,† 2019






Percentage of High School Students Who Drank One or More Glasses Per Day of Milk,* 2017-2019[†]

Percentage of High School Students Who Drank Three or More Glasses Per Day of Milk,* by Sex,† Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Drank Three or More Glasses Per Day of Milk,* 2017-2019[†]

Percentage of High School Students Who Did Not Eat Breakfast,* by Sex, Grade, and Race/Ethnicity,† 2019






Percentage of High School Students Who Did Not Eat Breakfast,* 2013-2019[†]

Percentage of High School Students Who Ate Breakfast on All 7 Days,* by Sex, Grade,† and Race/Ethnicity,† 2019






Percentage of High School Students Who Ate Breakfast on All 7 Days,* 2013-2019[†]









Percentage of High School Students Who Watched Television 3 or More Hours Per Day,* by Sex, Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Watched Television 3 or More Hours Per Day,* 2003-2019[†]

Percentage of High School Students Who Played Video or Computer Games or Used a Computer 3 or More Hours Per Day,* 2005-2019[†]




Percentage of High School Students Who Attended Physical Education (PE) Classes on 1 or More Days,* 2003-2019[†]

Percentage of High School Students Who Attended Physical Education Classes on All 5 Days,* by Sex,† Grade,† and Race/Ethnicity, 2019





Percentage of High School Students Who Attended Physical Education Classes on All 5 Days,* 2003-2019[†]





Percentage of High School Students Who Played on at Least One Sports Team,* 2003-2019[†]










Percentage of High School Students Who Saw a Dentist,* by Sex,† Grade, and Race/Ethnicity,† 2019



Percentage of High School Students Who Never Saw a Dentist,* by Sex,† Grade,† and Race/Ethnicity, 2019





Percentage of High School Students Who Got 8 or More Hours of Sleep,* by Sex, Grade,† and Race/Ethnicity, 2019





Percentage of High School Students Who Described Their Grades in School As Mostly A's or B's,* by Sex,† Grade,† and Race/Ethnicity,† 2019






Percentage of High School Students Who Described Their Grades in School As Mostly A's or B's,* 2003-2019[†]

Percentage of High School Students Who Most of the Time or Always Feel Safe and Secure at School, by Sex, Grade, and Race/Ethnicity,* 2019





Percentage of High School Students Who Bullied Someone on School Property,* by Sex,† Grade,† and Race/Ethnicity, 2019




Percentage of High School Students Who Bullied Someone on School Property,* 2017-2019[†]




Percentage of High School Students Who Electronically Bullied Someone,* 2017-2019[†]




Percentage of High School Students Who Did Something to Purposely Hurt Themselves Without Wanting to Die,* 2009-2019[†]




Percentage of High School Students Who Were in the Same Room with Someone Who Was Smoking Cigarettes,* 2009-2019[†]






Percentage of High School Students Who Currently Used Methamphetamines,* by Sex,† Grade,† and Race/Ethnicity, 2019


Percentage of High School Students Who Currently Used Methamphetamines,* 2017-2019[†]


Percentage of High School Students Who Attended School Under the Influence of Alcohol or Other Illegal Drugs,* 2007-2019[†]









Percentage of High School Students Who Saw a Doctor or Nurse,* by Sex, Grade, and Race/Ethnicity,† 2019




Percentage of High School Students Who Saw a Doctor or Nurse,* 2017-2019[†]




Percentage of High School Students Who Did Not Go to School Because They Were Sick or in Pain,* 2017-2019[†]

Percentage of High School Students Who Have Physical Disabilities or Long-Term Health Problems,* by Sex, Grade,† and Race/Ethnicity, 2019






Percentage of High School Students Who Have Physical Disabilities or Long-Term Health Problems,* 2017-2019[†]




Percentage of High School Students Who Have Long-Term Emotional Problems or Learning Disabilities,* 2017-2019[†]
